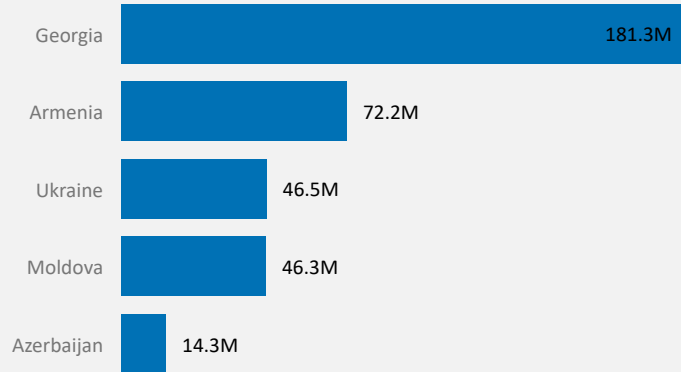

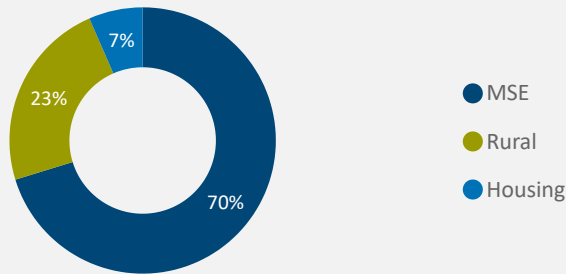

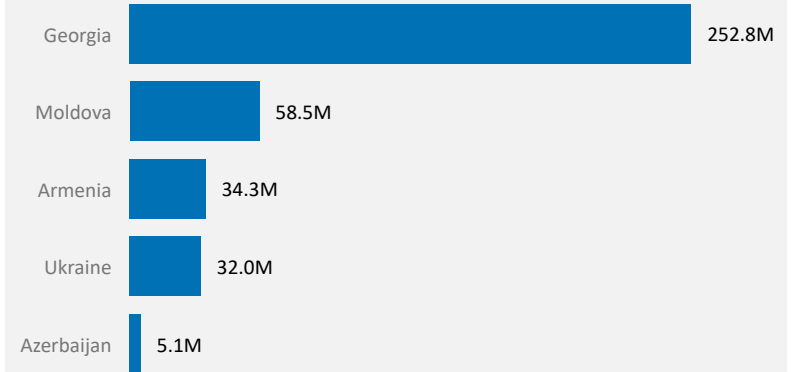

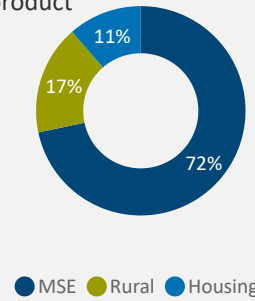

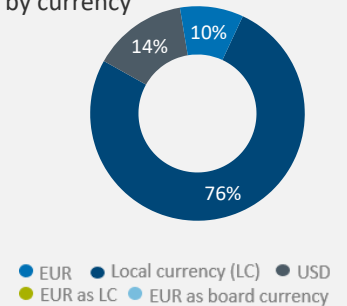
## Outstanding sub-loans by country
